Stamford Agriscience Doggy Daycare and Grooming Program is a student and school run facility and must always be prepared for an emergency situation. In the event of inclement weather, a school evacuation, or any other emergency or situation that may arise, the Stamford Agriscience and Technology Center will make the attempt to contact the clients to inform them of the situation using the contact information provided by the client in this packet.

If the client cannot be contacted or the dog cannot be picked up within one hour of the closing of school, their animal may be kenneled for the night with available food and water and the animal may be picked up the following day.

GROOMING PET RELEASE: Stamford Regional Agriscience and Technology Center's Doggy Daycare and Grooming Program

I warrant that my dog is current with the vaccinations required by law and that my dog is healthy to the best of my knowledge.

I understand that this is a learning experience for high school students and that this is NOT a professional service. Although students are instructed in safe grooming techniques and practice precaution, I understand irritation and/or nicks to the skin may occur and agree not to hold Stamford Regional Agriscience and Technology Center responsible for injuries to the skin that result from clipping, scissoring, trimming, or other grooming processes. This also includes the grooming and removal of mats on your dog as they are often difficult to remove and may be irritated or sensitive to your dog. I also understand that if at any time during the grooming process my pet, or the student, shows signs of discomfort, anxiety, or aggression, the grooming process will be stopped and I may seek a professional to complete the groom.

If you have an older dog or dog with any special conditions (arthritis, bone or joint problems, surgical-related problems, or anything else), the grooming process may be stressful for your dog. Although Stamford Regional Agriscience and Technology Center's Doggy Daycare Program will take every care in grooming my older dog or dog with special conditions, I acknowledge that the stress of grooming may initiate stress-related problems in my pet. I agree not to hold Stamford Regional Agriscience and Technology Center responsible for reactions to grooming.

Safety of the dogs, students, faculty, and staff are most important to us. Stamford Regional Agriscience and Technology Center's Doggy Daycare and Grooming Program reserves the right to refuse service to clients whose pet may pose a threat to students, staff, faculty, or other dogs left in our care, whether it be an aggression problem, health problem, or parasite problem. We also reserve the right to use a muzzle on your dog if necessary during grooming processes.
